Which KM services do you use?

You may be in contact with KM in various ways.

You are searching for a home, or you wish to let or lease a residential dwelling and give KM the assignment to do so.

- You would like to let your home. See 1.
- You would like to lease a residential dwelling. See 2.
- You are giving KM the assignment to sell a property for you. See 3.
- You are giving KM the assignment to search a property for you. See 4.
- You would like to view a property offered by KM, free of obligation. See 5.
- You would like to be kept up-to-date with what KM has to offer, free of obligation. See 6.
- You would like KM to value a property (free of obligation or otherwise). See 7.

We take your privacy seriously

KM takes your privacy very seriously and considers the rules governing data protection to be logical standards of decency. KM processes your data exercising due care and in accordance with the provisions of the law. KM devotes a great deal of attention to ensuring appropriate security, so as to protect your data against unauthorised use, access and amendment, and against unlawful destruction. KM constantly invests in the provision of good services.

Inspecting, amending or deleting data

If you would like to know what data of yours KM has, please send a request to the relevant office by letter or email. KM does not process names or any other directly identifiable data. If you would like to know what data KM processes, please contact a KM real estate agent, who will then ensure that you are informed accordingly. Should you wish to amend or delete any data, please send a letter or email message to KM setting out your reasons. Your request will be acceded to as soon as possible, unless the law renders it mandatory to retain your data or if there are other compelling grounds which pose an obstacle to such amendment or deletion.

How can you submit a complaint?

If you have any questions or in the event that you have a complaint about KM's use of data, please first contact the relevant office. Should you fail to resolve the issue with the relevant Koops office, you may contact Mr S. Koops, the founder, at sander@koopsmakelaardij.nl. Mr Koops will handle your complaint in such a situation. In addition, you are also entitled to submit a complaint to the Dutch Data Protection Authority.

How long will an NVM [Dutch Association of Real Estate Agents and Property Valuers] real estate agent store your data?

KM will not store your data for longer than is necessary. Nevertheless, KM does store some data for a lengthy period of time.

- KM keeps some data about the services which it provides for no longer than 12 months, because it may be held liable for any professional errors during that period.

Koops Makelaardij's use of data

Through a link KM supplies certain data to Pararius, the NVM, VBO and other relevant organisations. KM has consented to such other relevant organisations serving as controllers in relation to the data that has been received.

A KM's residential dwellings and investment properties currently on offer

If you wish to let or sell a residential dwelling or investment property through KM, the following information will be disclosed to other registered agents.

- the address of the relevant residential dwelling or investment property, its description and features, such as the asking price, the construction year, its surface area and layout, its land registry details, its WOZ [Immovable Property Valuation Act] value and photographs of the property.
- the date on which the property came onto the market and the date on which it was removed from the market. Conditional sale, date of sale and transaction price.

Koops Makelaardij uses this information for the provision of services to their customers (anyone searching for a residential dwelling or investment property).

Such information is kept without limitation for the purposes of a historical database of available properties. See C.

B Residential dwellings or investment properties currently available through housing and other websites, including Funda and Pararius

If you wish to sell or let a residential dwelling, or a commercial or agricultural property through Koops Makelaardij, information will also be disclosed to Funda and other websites (housing or otherwise) after consulting you. This will involve the following information:

- the address of the relevant residential dwelling, or commercial or investment property, its description
 and features, such as the asking price, its construction year, its surface area and layout, its land
 registry details, its WOZ [Immovable Property Valuation Act] value and photographs of the property.
- the date on which the property came onto the market and was sold or let.

Using this information, your property will be brought to the attention of consumers, professional agents and/or any other parties that search housing and other websites. You may consent to KM doing this or not.

Such information may still be visible on those websites for up to no more than one (1) year following the relevant date of sale or that on which the residential dwelling, or commercial or investment property is removed from the market.

C Historical database of available properties

The following information about all of the residential dwellings which are let or sold through KM is entered into the KM database:

- the address of the relevant residential dwelling, or commercial or investment property, its description
 and features, such as the asking price, its construction year, its surface area and layout, its land
 registry details, its WOZ [Immovable Property Valuation Act] value and photographs of the property.
- the date on which the property came onto the market and the date on which it was removed from the market. Conditional sale, date of sale and transaction price.
- the postcode (1234AB) of the buyer's previous residential or other address.

The above-mentioned details are kept indefinitely.

KM makes it possible to produce analyses of the housing market using the above-mentioned information. KM supplies such information to other selected parties, namely:

- valuers to enable them to conduct evaluations and determined values;
- validation institutes for the purposes of verifying valuation reports;
- municipalities for the purposes of determining WOZ values;
- real estate agents to enable them to provide services to their customers.

Those parties only have access to that information for the above-mentioned purposes and, where possible, information is only supplied in aggregated form.

If you wish to inspect, amend or delete data processed by KM, please contact the office which has provided assistance for the purposes of letting or selling the relevant residential dwelling, or commercial or investment property.
